SPECIFIC TERMS AND CONDITIONS:

- The minimum reserve bid for the asset is fixed at 75,00,000 (Rupees Five Lakh only) per annum, for a contract period of five (05) years, subject to satisfactory performance by the bidder and on time payment of dues. A compound escalation of 10% shall apply for each successive year. The bid amount shall be deposited annually in advance before the commencement of each allotment year.
 - The asset is auctioned on "As Is Where Is" basis. All prospective bidders must physically inspect the asset before participating in the e-bidding process. No claims regarding major deficiencies, rectifications, or alterations in the asset shall be entertained thereafter.
 - No structural alteration, addition, or expansion to the footprint and bulk of the structure beyond the existing plinth area and height of the structure shall be permitted under any circumstances.
 - Any repairs or renovation shall be carried out only after obtaining prior written approval of the competent authority and technical vetting by the R&I Department. Unauthorized modification shall invite termination of the contract without notice.
 - All repairs, including electrification and sanitation, shall be carried out by the bidder at their own cost after obtaining departmental approval.
 - The bidder shall independently arrange any additional furniture, electrical backup, and standard crockery/cutlery for service operations.
 - The bidder shall ensure that the shop front, counters, furniture, and display boards are kept clean, orderly, and visually appealing. Use of plastic flexes, loud music, or cluttered displays is prohibited.
 - The bidder shall not encroach upon or obstruct pedestrian movement, sidewalk, or access to the ski lift under any circumstances. Seating, queue lines, and temporary counters must remain within the demarcated area allotted by GDA.
 - The bidder shall use only eco-friendly and biodegradable cups, plates, spoons, and packaging materials. Use of single-use plastics, polythene, or thermocol shall be prohibited.
 - The bidder shall maintain and operate the asset in a professional, hygienic and aesthetically pleasing manner. Any structural facade, cladding, or modifications shall be carried out only by the advice and design of a recognized architect and upon obtaining written permission from this authority.
 - Failure to maintain the premises in sanitary, operational, or secure condition as required under the contract shall attract a penalty of Rs. 5,000/- (Rupees Five Thousand only) per day without prejudice to the Authority's right to terminate the contract.
 - The bidder shall make independent arrangements for staffing, stationery, and all other operational needs. Only professionally qualified and trained personnel shall be employed by the bidder for service delivery.
 - The bidder shall provide uniforms and ID/name plates to the staff. The bidder shall be vicariously liable for any misconduct or unlawful acts by his/her staff.
 - The bidder shall ensure courteous and satisfactory service. Any complaints of misbehavior or substandard service shall attract penal action including cancellation of the allotment and termination of agreement.
 - All equipment must be eco-friendly and shall be installed only after prior approval.
 - The bidder shall make adequate arrangements for the safe disposal of solid and liquid waste and shall ensure compliance with all pollution control/environmental protection norms.
 - The bidder shall be solely responsible for the security and maintenance of the property, lawns, and landscape, if any. No departmental staff shall be posted for the same.
 - The premises shall be subject to inspection by authorized officials of GDA. In case of unsatisfactory performance, the contract may be cancelled summarily.
 - The bidder shall coordinate with Tourism Department staff, if any, stationed at the site for smooth operation.
 - Sub-letting of the premises is strictly prohibited. In case of premature vacation, a three-month prior notice and payment of full lease amount for the remaining year is mandatory.
 - Daily cleaning, sweeping, and general upkeep shall be maintained by the bidder. Any failure may result in enforcement of remedial action at the bidder's risk and cost.
 - The bidder shall prominently display approved rates for all services within the premises particularly at the entrance.
 - The bidder shall maintain proper record of all collections made from users, including issuance of printed or digital receipts for each transaction for tax purposes. The bidder shall also provide a facility for online and cashless payments, including UPI, QR code, etc approved by the Government, to ensure convenience for users.
 - Guest registration, maintenance of visitor records including identity verification as per legal requirements, and compliance with applicable laws such as Registration of Tourists Act, Police Verification Rules, and taxation obligations shall be mandatory. Digital registration and submission of accommodation data to the designated authority shall also be ensured.
 - The bidder shall be solely responsible for the safety, upkeep, and maintenance of the asset throughout the contract period. The bidder shall ensure adequate safety measures, including availability of first aid and fire-fighting equipment.
 - Any proven case of negligence or poor performance shall lead to immediate termination of contract without notice.
 - Provision and upkeep of heating systems appropriate for winter conditions shall be ensured. The use of open fires, high-emission fuel, or any heating equipment that may pose a safety hazard or cause environmental degradation shall be disallowed without specific written permission.
 - A gestation period of 45 days or as deemed fit by the Authority or actual commencement of operations (whichever is earlier) shall be allowed.
 - Upon expiry of the lease, GDA shall retain possession of the premises without any further notice. In case of overstay beyond the contract period, charges shall be levied at 710,000 per day for the first 10 days and 720,000 per day for the next 10 days. Thereafter, legal proceedings for eviction shall be initiated.
 - The bidder shall insure the property in the name of the Chief Executive Officer, Gulmarg Development Authority, through a Nationalized Insurance Company. The premium shall be borne by the bidder, and the insurance certificate must be submitted within two weeks from the day of allotment.
 - The bidder shall operate the double bedroom hut strictly for the purpose of visitor accommodation and related hospitality services. Any conversion of the premises into a restaurant, bar, or retail outlet beyond the approved scope shall be strictly prohibited.
 - Room interiors, furnishings, bedding, and sanitary facilities shall be maintained to tourism-grade standards. Minimum hospitality standards (such as linen change, cleanliness turnaround time, water supply, heating, and lighting) shall be adhered to at all times, subject to inspection by GDA or Tourism Department officials.
 - No permanent branding, hoardings, or exterior signage, except the approved nomenclature plate with the GDA logo, shall be affixed. Ensuring harmony with the natural aesthetics and alpine character of Gulmarg shall be paramount.
 - The bidder shall obtain a re-new license/permissions from competent authorities, wherever applicable.
 - Any damage to the structure, furniture, utilities, or landscape shall be restored by the bidder at their cost prior to handing back possession. Restoration charges, if not complied with voluntarily, may be recovered from the security deposit or by legal recourse.
- GENERAL TERMS AND CONDITIONS:**
- Only eligible bidders who uploaded all relevant documents and submitted an EMD in the form of a CDR for the amount mentioned above and pledged to the Accounts Officer, Gulmarg Development Authority, shall be permitted to participate.
 - The participant in the e-bid must apply in their individual name or in the name of a registered firm as reflected in the uploaded PAN and GST certificates to be uploaded on GeM Portal.
 - No serving employees of any Government Department or Public Sector Undertaking shall be eligible to participate in the bidding process.
 - The successful bidder shall deposit the Successful Bid Amount i.e., full amount upfront within seven (07) calendar days of the issuance of Letter of Intent, failing which the EMD shall be forfeited. In case of the due date of payment is a Saturday, Sunday or a public holiday, the due date for payment will be considered as the next working day.
 - The successful bidder shall execute a formal agreement with the department within seven (07) days from the date of issuance of the Letter of Allotment, on a Non-judicial Stamp Paper, along with an undertaking to comply with all terms and conditions. All expenses related to the preparation and execution of the agreement shall be borne by the bidder.
 - The bidder has to pay GST @ 18% of the offered bid. All other applicable taxes including, Income Tax, Labour Cess, and any other taxes as may be levied under the law shall be paid by the bidder on its own under an intimation to this office. The bid amount is exclusive of these statutory dues.
 - Electricity, water charges and other ancillary charges shall be borne by the bidder as per actual consumption and prevailing tariffs.
 - Bids deemed anomalously high, aimed at disrupting the auction process, may be rejected and such bidders may be blacklisted.
 - Without prejudice to the generality of the foregoing, GDA reserves the right to summarily disqualify/reject any or all bids at any stage of the Auction or after the Auction is completed on grounds of non-compliance with eligibility conditions, misrepresentation, non-compliance with the relevant Auction Rules, non-compliance with any other pre-condition prescribed for participating in the Auction or any matter that may, in the opinion of the Authority, be contrary to general public interest without assigning any reason to the bidders.
 - GDA reserves the right to halt the e-Bidding process at any stage if any irresponsible bidding or attempts to disrupt the auction process were observed. Such intimation shall be issued through the "Messages" on the GeM portal.
 - The Bidders and their respective employees, agents and advisers shall observe the highest standard of ethics during the tender process and subsequent to the issue of the allotment and during the subsistence of the Agreement. Notwithstanding anything to the contrary contained herein, or allotment order or the Agreement, the Authority may reject a Bid, withdraw the allotment order, or terminate the Agreement, as the case may be, without being liable in any manner whatsoever to the Bidder, Qualified Bidder, or the Successful Bidder, as the case may be, if the Authority determines that the Bidder has, directly or indirectly or through an agent, engaged in Corrupt, Fraudulent, Coercive, Undesirable or Restrictive Practice in the tender process. In such an event, the Authority shall be entitled to forfeit and appropriate the EMD or deposited amount as damages, without prejudice to any other right or remedy that may be available to the Authority.
 - Bidders with outstanding dues or history of defaulting on payments shall not be eligible to participate in the auction.
 - If the bidder abandons the contract midway, or if the agreement is cancelled due to non-compliance or non-payment, the EMD/CDR shall be forfeited.
 - Any damage to Government property shall be recoverable at double the cost assessed by the R&B Engineering Wing. Violations will lead to contract cancellation.
 - The department reserves the right to use the premises for official purposes/events, without payment of rent to the bidder.
 - The bidder shall comply with all departmental and statutory directions issued from time to time concerning law and order, sanitation, environment, and public interest.
 - Conditional offers or proposals in deviation from tender terms shall be summarily rejected.
 - Any dispute arising between the parties shall be referred for arbitration to the Director, Tourism Kashmir (Chairman Outsourcing Committee GDA), who shall act as sole arbitrator. The decision of the arbitrator shall be final and binding.
 - The Gulmarg Development Authority reserves the right to terminate the contract at its sole discretion, without assigning any reason, by giving 30 days' written notice to the Allottee. In such a case, no claim for compensation or damages shall be entertained.
 - No extension shall be granted under any circumstances, including natural calamities or any Force Majeure events. The asset shall be re-auctioned upon contract completion.
 - The Gulmarg Development Authority shall not be responsible or held liable for any kind of loss to the revenue sustained by the bidder due to Force Majeure events, including by reason of war, or hostility, acts of the public enemy, civic commotion, sabotage, Act of State or direction from Statutory Authority, explosion, pandemic or epidemic, quarantine restriction, strikes and lockouts, fire, floods, natural calamities or any act of God etc, that are beyond the control of GDA.

سرینگر، جموں و کشمیر انتظامیہ نے جاری 100 روزہ "نشہ مکت جے اینڈ کے ابھیان" کے تحت نمایاں پیش رفت حاصل کی ہے، جو نشیات کے استعمال سے ششپنے، بحالی کے طریقہ کار کو مضبوط بنانے اور پورے جموں و کشمیر میں ناکہ کے خلاف آفاقیہ دہک کو تیز کرنے کیلئے حکومت کے ایک جامع نقطہ نظر کی عکاسی کرتا ہے۔

صحت، سماجی بہبود، اطلاعیت، پولیس، تعلیم اور دیگر محکمہ اہلکاروں کے جموں میں نمایاں عوامی شرکت اور ادارہ جاتی رابطہ کاری کے ساتھ جم نے شروع سے آج تک سبے مثال کامیابی بھی دیکھی ہے۔

مہم کے تحت جموں و کشمیر میں کل 216123 بیداری پروگراموں کے ساتھ بڑے پیمانے پر عوامی رسائی اور بیداری کے پروگرام منعقد کئے جا رہے ہیں جن میں ایک کروڑ سے زیادہ شرکاء شامل ہیں، کا مقصد نشیات کے استعمال کے صغر اثرات کے بارے میں عوام کا گہرا آگاہ کرنا ہے۔

جموں و کشمیر میں نشیات کے خلاف کارروائیاں

سرچ آپریشن اور گرفتاریاں

جموں و کشمیر میں 100 روزہ نشیات کے تحت پولیس نے نشیات کے خلاف اپنی کارروائیاں مزید تیز کرتے ہوئے اہم ناگ، بڑگان اور ہندوارہ میں الگ الگ کارروائیاں میں چار نشیاتی فروشوں کو گرفتار کر لیا ہے اور ان کے قبضے سے قابل اعتراض و ممنوعہ مواد برآمد کیا گیا ہے۔

پولیس انسپشن لارو کے تحت آنے والے علاقے میں معمولی ایکٹ کے دوران کھرنی لارو میں ایک مشتبہ شخص کو روکا گیا۔ تلاشی کے دوران کئی کے پھانسیوں میں لپٹی ہوئی چرس 6 گرام (تقریباً 96 گرام) برآمد ہوئیں۔ گرفتار شخص کی شناخت غلام نبی ریڈ ولد غلام رسول ریڈ ساکن فریو گاؤں، اہلن کوکرناگ کے طور پر ہوئی ہے۔ نشیات کو موقع پر ہی ضبط کیا گیا۔ پولیس پوسٹ واٹری ہال کی ٹیم نے راولپورہ، خاصا صاحب میں تا کہ چیکنگ کے دوران دو نشیاتی فروشوں کو گرفتار کیا۔ پہلے طرم نذیر احمد گنی ولد عبدالرحمن گنی ساکن رکھانے اریال کے قبضے سے 27 گرام چرس خاماوا برآمد ہوا۔

ابتدائی پوچھ تاچھ اور بیک ورڈ سچ کے دوران دوسرے طرم محمد رفیق خان ولد عبدالرحمن خان ساکن اریال کی شناخت ہوئی، جس کے قبضے سے تقریباً 7 کو 740 گرام چرس خاماوا ضبط کیا گیا۔ پولیس کے مطابق یہ کامیابی نشیات کے ایک بڑے نیٹ ورک کی کڑیوں کو بے نقاب کرنے کی طرف اہم پیش رفت ہے۔

ادھر پولیس پوسٹ لکھیٹ کی ٹیم نے گندھکوش میں پائی الرٹ تا کہ چیکنگ کے دوران ایک مشتبہ شخص کو فرار ہوتے دیکھ کر تعاقب کیا اور گرفتار کر لیا۔ تلاشی کے دوران اس کے قبضے سے اسپسو پروسیون پلس ممنوعہ دوائی برآمد ہوئی۔ گرفتار شخص کی شناخت سبیل منظور ڈار ولد منظور احمد ڈار ساکن مرہٹا، ہندوارہ کے طور پر ہوئی ہے۔
